1. Competitive advantages of the Educational Programme

“Bachelor of Law”:

The educational programme is aimed at training a new generation of lawyers who are able to implement independently and in a team in the main areas of legal activity.

The educational programme makes it possible to form the following practical skills in the field of law:

- skills of effective work with sources of law, taking into account their legal force, actions in time, space and circle of persons;
- ability to evaluate and interpret current legislation, contracts and other regulators of public relations;
- skills to work with significant amounts of specialized information of normative and doctrinal nature;
- skills of interaction with other people, ability to work in groups, as well as skills of active participation within the framework of the general trial and defending their own position;
- skills in organizing professional activities, planning and time management, correct and clear setting of tasks and priorities;
- the ability to provide the correct legal qualification of individual evidence, facts, legal norms and other elements, both independently and in their totality in a legal case, taking into account the peculiarities of a particular situation;
- the ability to make procedural decisions, to form a legal position on the case and to reflect it in the text of the legal document;
- skills of preparation, conclusion, legal support of cases, as well as preparation and preparation of other legal documents in the areas of administrative, criminal, civil, economic, financial, family, and inheritance law, etc.;
- skills of a business entity registration and preparation of documents of its activities;
- skills to apply basic techniques for identifying, fixing and researching evidence;
- skills to solve mental problems in planning and organizing the legal process, solving a legal case;
- obtaining skills of qualification and investigation of criminal offenses within the framework of criminology, forensics, acquaintance with procedural aspects of participation in the criminal process;
- skills in procedural areas of law, in particular, knowledge and practical skills necessary for proper participation in litigation within the framework of civil,

economic, criminal proceedings, preparation and submission of procedural documents to the court;

- transnational legal thinking skills and the application of collision norms, as well as the norms of foreign law systems.

2. A high level of training is achieved by providing them with European-level knowledge of the following **main professional disciplines**: theory of state and law, constitutional law, civil law, criminal law, labor law, administrative law, commercial law, civil procedure, criminal process, administrative process, economic process, criminalistics, private international law, intellectual property law, European Union law, advocacy, notary service board, prosecutor's office, legal services of legal entities, information technology in legal activities, psychology and ethics of business communication, foreign language in professional use, etc.

3. **Our graduates can hold the following positions**: assistants of judges, assistants of notaries, assistants of lawyers, public and private executors, police officers, investigators, legal advisers, specialists, advisers and consultants of enterprises, institutions and organizations of various forms of ownership, positions in legislative authorities, public administration and local governments, justice, etc.

Graduates have the opportunity to study the programmes of the second (Master's) and the third (Doctor of Philosophy) cycles of education.
